August 21, 2017 –The Minister of Environment and Climate Change, the Honourable Catherine McKenna, has requested additional information on the environmental assessment for the proposed Deep Geologic Repository (DGR) Project for Low and Intermediate Level Radioactive Waste in Kincardine, Ontario.

On July 24, 2017, the Saugeen Ojibway Nation <u>wrote</u> to the Minister, stating that the communities are engaged in a community-driven process in order to make a well-informed decision on whether they can support the DGR project. This process relates to a commitment made by Ontario Power Generation (OPG) to the Saugeen Ojibway Nation that OPG would not move forward with the project until the Nation's communities are supportive of it.

In light of OPG's commitment to the Saugeen Ojibway Nation and the Saugeen Ojibway Nation's letter of July 24, 2017, the Minister has issued a <u>request for additional information</u> to OPG to update its analysis of the potential cumulative effects of the project on physical and cultural heritage. The results of the Saugeen Ojibway Nation's process must inform this analysis and be incorporated in the proponent's response.

Following the submission of the updated cumulative effects analysis, the Agency will make available a draft report and potential conditions for comment by the public and Indigenous groups.
