**Mitchell Leads House Letter Asking Administration to Urge Canada to Halt Nuclear Waste Project**

**Washington, D.C.** – Representative Paul Mitchell (MI-10) sent a bipartisan letter with twelve of his House colleagues asking the Trump administration to urge Canada to halt the Ontario Power Generation (OPG) proposal to store nuclear waste near Lake Huron. Representative Mitchell issued the following statement after releasing the letter:

“The Great Lakes make up one fifth of the world’s fresh surface-water supply and are a source of drinking water for 40 million people. This plan poses a danger to a crucial water source and a failure at the site would disrupt both Michigan and Canadian tourism and commerce.

I ask the Trump administration to urge our Canadian neighbors to identify a more suitable location outside of the Great Lakes basin to protect the citizens and the environment of both nations.”

**BACKGROUND**

OPG, a Canadian energy company has proposed to build a nuclear waste facility in Kincardine, Ontario. OPG’s current proposal is to permanently store low and intermediate level radioactive waste 2,000 feet underground the shore of Lake Huron. Michigan’s 10<sup>th</sup> Congressional District,

represented by Congressman Mitchell, relies on Lake Huron as a critical water source and tourist attraction.

Dear Mr. President:

As you establish your Administration's priorities and operations, we would like to bring to your attention Ontario Power Generation's (OPG) proposed permanent nuclear waste storage facility in Kincardine, Ontario, Canada. We ask you to encourage your counterparts in the Canadian government to deny OPG's proposed site and have the company explore other options.

As you know, the Great Lakes are one of our country's greatest resources. It is the world's largest network of freshwater lakes, and millions of Americans and Canadians depend on them for drinking water, recreation, and commerce. Furthermore, the natural beauty of the lakes is undeniable. It is in our national interest to protect these lakes for generations to come.

Nuclear power, while an important source of electricity, requires safe disposal and storage of the resultant nuclear waste. OPG's current proposal is to permanently store low and intermediate level radioactive waste 2,000 feet underground on the shore of Lake Huron. Given the close proximity of the Great Lakes, and the vast amounts of land available for alternate sites, OPG's proposal is an unnecessary risk.


In spite of these concerns, according to a recent report from OPG, "there is little interest among the general public regarding the [deep geologic repository] project." We emphasize that is not the case, and we encourage you convey that sentiment to the Canadian government.

Thank you for considering our request and taking into account the concerns of our constituents. We look forward to working with you to resolve this issue.


